Notes:

1. Off-season is considered November 1 through March 31.
2. Weekend is Friday, Saturday, Sunday.
3. The air-conditioned pavilions are available at no charge for official functions of the Board of County Commissioners and the Gilchrist County School. At the park manager's discretion, other uses of the pavilions may be allowed free of charge where the proposed function is directly related to the mission of promoting safe and enjoyable use of Gilchrist County's recreational resources. This may include, but is not limited to: the Gilchrist County River Cleanup planning and organizations meetings, the Tri-County Tourism Taskforce, and the Hart Springs Flotilla 7-14 of the US Coast Guard Auxiliary.
4. A person must be 18 years or older to rent park facilities.
5. There will be a \$10.00 processing fee for all refunds (this will be charged per transaction.)
6. The fees above do NOT include applicable State and County tax, excluding daily admissions.
7. No grills may be started after 6:30 P.M. and the Park closes for day users at 7:30 P.M.

HART SPRINGS PROCESSING CHARGE AND NO REFUND GUIDELINES

SECTION 4.1 HART SPRINGS PARK

Admissions: Admission refund only if refund is requested within 20 minutes of arrival. No refund due to violations of park rules (ex. Alcohol, fighting, excessive cursing, etc. resulting in being asked to leave the park).

No refund due to rain: Swimming is suspended during lightning events.

Open Shelter Rental: There will be a \$10.00 processing fee for any refunds requested more than 7 days before a reserved date. There will be no refunds for cancellations that are requested within 7 days of a reservation date.

House rentals: There will be a \$10.00 processing fee for any refunds requested more than 30 days before a reservation date. No refunds will be issued within 30 days of a reservation date.

Camping: There will be a \$10.00 processing fee for any refunds requested more than 8 days of a reservation date. There will be no refunds for cancellations that are requested within 8 days of a reservation date.
